

WBNQ Official Contest Rules (2006-2007)

1. All telephone calls to the WBNQ studios may be recorded in whole or in part for future broadcast.
2. Unless otherwise specified, winners have thirty days from the date of winning to pick up their prizes at the Radio Bloomington offices located at 236 Greenwood Avenue in Bloomington during regular business hours; Monday through Friday 8a -5p excluding holidays.
3. After the 30 day time period all unclaimed prizes will be forfeited and will become property of WBNQ.
4. In the event that the prize is not available on the date the prize is won, the winner will have 30 days from the date the prize becomes available to claim their prize. In this scenario, the winner will be notified when prize is available.
5. Winners must provide their full legal name and address and must present legal identification to claim all prizes.
6. Winners must be a resident of Illinois or maintain a residence within the area covered by the WBNQ terrestrial radio signal.
7. Winners grant Regent Communications permission to use their name, likeness, and voice for promotional purposes without additional consideration.
8. Unless otherwise indicated, winners must be at least 12 years of age. Alternate age requirements and restrictions may be imposed for specific contests.
9. Listeners are restricted to one prize valued at \$99 or less every two weeks, but are still eligible for larger prizes. Listeners are restricted to one prize valued between \$100 and \$999.99 every 90 days, and prizes valued at \$1000 or more once per 365 days.
10. Winners who accumulate prizes totaling \$450 or greater in value within a calendar year will be required to provide their SSN or Tax I.D. number.
11. Winners who accumulate prizes totaling \$600 or greater in value within a calendar year are subject to taxes and will be required to fill out the proper forms as required by Federal Law.
12. For an individual prize or prize package valued at over \$600, the completion of these tax forms is a condition of winning the prize. A 1099 form will need to be completed prior to taking possession of the prize(s)
13. Winners are responsible for all taxes, fees and duties that result in the acceptance of any prize.
14. No purchase required.
15. Prizes are non-transferable and have no redeemable cash value.
16. Regent Communications/WBNQ is not obligated, for any reason, to replace a prize after it has been claimed.
17. Employees of Regent Communications, affiliated advertising agencies, participating sponsors, promotional partners, other electronic and print media employees and their immediate families are not eligible to win.
18. Regent Communications/WBNQ reserves the right to change or amend all contest rules. Failure to comply with contest rules may result in disqualification.
19. Contests may be cancelled at any time without prior notice
20. Regent Communications/WBNQ reserves the right to replace or substitute any prize with one of equal or greater value.
